1. The **scanned copy of the EMD is required to be uploaded on GeM portal as proof of depositing EMD. ## **2) Turnover**

## **3) Extension of the contract period/quantity/value:**

During the contract period, the Buyer reserves the right to extend the contract period for one year at the same contracted rates, terms and conditions. During the contract period at the contracted rates, terms and conditions, the Buyer reserves the right to increase or decrease the quantity of Security Manpower or contract value up to 50%. ## **4) Type of Bid**

## **5) Penalty for Delay in deployment of Security Personnel**

The successful bidder/ contractor shall be given one week's time to provide eligible and qualified candidates for new/substitute positions. Failure in meeting the stipulated 01 week's timeline, a penalty of Rs. 1000/- per Manpower (Security Personnel) shall be imposed per week and part thereof on the contractor. The penalties, if any, shall be recovered from the earliest due payments of the contractor from the part of service charges dues. The penalty will be applicable over and above the salary deduction for the absent period.

- 6) Bidder is to ensure that only Ex-Servicemen are deployed for duty. A self-certificate in this regard needs to be submitted by the bidder while applying for the bid.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
