Director General, National Communications Academy (NCA-T), Ghaziabad invite s online bids from eligible and interested Bidder(s) for "upgrade the existing 5G Use Case Lab with 5G Industrial IoT (IIoT) Gateway" at NCA-T, Ghaziab ad through bidding on GeM Portal.

#### i. EMD:

EMD, if not exempted, to be deposited in form of Fixed Deposit/Demand Draft/Pay Order in favour of **AO (Cash) TEC payable at New Delhi** and details like Name of Bidder, Address of Bidder and EMD in connection with "**Hiring of Consultants**" must be mentioned at the back. The same may be deposited by registered post or in person to **AD (MM), Room No 705, NCA-T Campus, Ghaziabad-20 1002** before the last participation date of the bid. The **scanned copy of the EMD is required to be uploaded on GeM portal as proof of depositing EMD. Failure to furnish EMD** (if Not Exempt ed) to AD (MM), Room No 705, NCA-T, Ghaziabad -201002 before the last date/time of bid submission **will result in rejection of the bid.** 

#### ii. Extension of the contract period/quantity/value:

- a. Initially the contract will be awarded for a period of one year, which may be extended for one more year on satisfactory performance and if services/items required.
- During the contract period at the contracted rates, terms and conditions, the Buyer reserves t
  he right to 50% increase or decrease in the quantity of deliverables and/ or contract value. Thi
  s shall also be applicable for extended period of contract, if any

#### iii. Eligibility Conditions

- Only those bidders should participate which are dealing with the supply of Wireless and 5G Equipment's.
- b. Bidders are required to submit MAF (Manufacturer Authorization Form) along with the bid **for the Industrial IoT (IIoT) Gateway**.
- c. The bidder must have successfully executed/completed similar supply over the last 01 year i .e. the current financial year and the last one financial years (ending month of March prior to the bid opening) to at least 02 govt. organizations/educational institutions, for a value of at le ast Rs. 10Lakh. Bidder is required to submit the successful installation/completion certificate.

#### iv. Similar Equipment for Past Experience:

In case of Past Experience of Similar equipment's for this tender constitute the Wireless Access and C ore Equipment's.

# v. Warranty and AMC:

- **a.** The Comprehensive Warranty on deliverable equipment's/software's etc. supplied is 02 year, followed 03 years of AMC (@5% of the bid quoted rate on fixed basis). AMC will be renewed every year on satisfactory performance.
- **b.** During the AMC period any repairs, software upgrades, hardware replacements, tuning, optimization, or c ustomization requirement shall be addressed and replaced at no additional cost.
