i. **EMD:**

EMD, if not exempted, to be deposited in form of Fixed Deposit/Demand Draft/Pay Order in favour of **AO (Cash) TEC payable at New Delhi** and details like Name of Bidder, Address of Bidder and EMD in connection with “**Hiring of Consultants**” must be mentioned at the back. The same may be deposited by registered post or in person to **AD (MM), Room No 705, NCA-T Campus, Ghaziabad-201002** before the last participation date of the bid. The **scanned copy of the EMD is required to be uploaded on GeM portal as proof of depositing EMD. Failure to furnish EMD (if Not Exempted) to AD (MM), Room No 705, NCA-T, Ghaziabad -201002 before the last date/time of bid submission will result in rejection of the bid.**

ii. **Extension of the contract period/quantity/value:**
