1. Director General, National Communications Academy (NCA), Ghaziabad invites online bids from eligible and interested Bidder(s) for **“Monthly Basis Cab & Taxi Hiring Services”** at NCA, Ghaziabad through bidding on GeM Portal.

- EMD, if not exempted, to be deposited in form of Fixed Deposit/Demand Draft/Pay Order in favour of **AO (Cash) TEC payable at New Delhi** and details like Name of Bidder, Address of Bidder and EMD in connection with **“Monthly Basis Cab & Taxi Hiring Services”** must be mentioned at the back. The same may be deposited by registered post or in person to **ADG (A & MM), Room No 705, NCA Campus, Ghaziabad-201002** before the last participation date of the bid. The **scanned copy of the EMD is required to be uploaded on GeM portal as proof of depositing EMD. Failure to furnish EMD** (if Not Exempted) to ADG (A & MM), Room No 705, NCA, Ghaziabad -201002 before the last date/time of bid submission **will result in rejection of the bid.**
- The Service Provider/contractor should be Delhi/NCR based or should have an office in Delhi/NCR.
- The firm participating in the bid should have **at least 1 Commercial Prime Sedan type** vehicle registered in the name of the firm/service provider/contractor. Relevant proofs like RC copy, permit etc. to be submitted.
- The unused/unutilised kilometres of the monthly Km. provisions (i. e. 1500 Km per month) in the bid/contract in the particular month will be carried forward for next three months.
