About the Webinar

The Telecommunications Act-2023, seeks to replace the Indian Telegraph Act, 1885 and the Indian Wireless Telegraphy Act, 1933. The Act has recently been passed in Lok Sabha & Rajya Sabha and will promote structural reforms in the telecom sector. The Act will usher in the biggest reforms in the sector as now there will be one simple authorization instead of 100 licenses. It will also strengthen the legal system for dealing with cyber-security issues. There is a provision for regulatory sandbox which will encourage innovation. The Act provides for stopping transmission and intercepting messages in case of public emergency, in the interest of the public, to prevent incitement for committing offence. Spectrum assignment methodology has been clearly defined with the default mode as "Auction". However, for certain purposes like Government, Security and where Auction is not feasible due to Technical and Economic reasons, administrative assignment has been prescribed. Such cases are listed in Schedule I of the Act. This webinar aims to discuss various aspects of the Act in length.
