2. DETAILS OF ARRIVAL AND TRANSPORT

On your arrival at the Indira Gandhi International Airport, New Delhi, after collecting your baggage from the appropriate belt and after finishing immigration formalities you may come out from exit gate number 5. 3. ONSITE REGISTRATION

The registration will be done at 9.30 am on 17/02/2024 at the training venue by filling up a Registration Form of NTIPRIT.

4. VISA REQUIREMENTS

All foreign visitors entering India must have a valid passport travel document with a minimum validity of six months beyond the period of stay and need to check visa requirements before entering the country. Participants who require a visa should apply for a visa at an India consulate or diplomatic mission in their respective country well in advance of their departure. The Embassy/Consulate may take up to two weeks for visa processing. Participants are also advised to obtain, before the commencement of their journey, and where necessary, transit visas for countries en route to India. As the visa requirements change from time to time, it is advisable to check your visa requirements with the nearest Indian Embassy before departure. 5. ACCOMODATION

Accommodation arrangements will be made at a hotel near to NTIPRIT Ghaziabad, India.

6. CURRENCY

The unit of currency is Indian Rupees which comes in denominations of 10, 20, 50, 100, 200 and 500. Please use authorized money changers and banks to change currency. They will issue a certificate of exchange which is required at the time of re-conversion of any unused currency. Under the Foreign Exchange Management Act, 999, it is an offence to exchange foreign currency other than through authorized money changers or banks. Foreign Exchange Rate is approximately INR 83.71 to USD 1.00 (as of July 2024).

Most bank ATMs honor Visa, Visa Electron, Master & Maestro cards & you may use these ATMs also to withdraw money. Most hotels, shops & other establishments accept credit cards. Master & VISA cards are accepted at almost all such establishments whereas some of them accept Diners & American Express cards as well.

7. ELECTRICAL APPLIANCES

As this city is well connected to New Delhi, its temperature and rainfall are quite similar to the National capital, Delhi.
